

## Technical Rider for Reuben and Ash Fast Horse

Presenter agrees to meet the following requirements :

1. Sound System, will be provide by Artist.
  - Enough electrical power to run system.
2. Dressing Room (Keep in mind, they will do costume changes during the show.)  
Presenter will provide a clean private dressing / warm-up room that is readily accessible to the performance stage (e.g. auditorium, gymnasium, theater, etc.).  
Dressing room shall have a staff person present when Artist is on stage.  
  
Dressing room shall have mirrors and, if possible, running water, soap, two chairs, and four clean towels.
3. Staging (Keep in mind "Dance" is a very important part of their presentation.)  
Stage dimensions should be a minimum of 20 ft x 20 ft. A small table, (min. 2 ft. x 3 ft.) on stage.  
Two staff members to help load in and then again to help load out, after the show.
4. Hospitality / Hotel  
Please provide the following:
  - Hot coffee or hot tea with sugar. - Two (2) one litter bottle drinking water.
  - If meal can be provided, hot meals are acceptable. Non fried and non fast-food), fresh vegetables, fresh fruit, 100% juice preferred.
  - One king size bed (if not available then 2 queen size beds), Non-smoking, On ground floor if possible King, with fridge and microwave, on ground floor. A small suite is perfect for the family. If you can not provide hotel, please add \$100 to payment.
5. Parking  
Please provide a reserved parking space, close to the venue, large enough for a SUV, that is pulling a trailer.
6. Merchandising  
Artist shall have the sole and exclusive right, but not the obligation, to sell compact discs and other items related to the Artist's performance. Artist shall retain 100% of revenue and therefore not be liable to any percentage of merchandise sales to the Presenter.
7. Audio and Video Recording  
There is to be no audio or visual recording of the performance without the written permission of Artists or Agent.
8. Modifications to this Agreement May be made only by mutual consent and by an instrument in writing signed by both parties.
